321. Public Question Time

- **Time of arrival and departure for Councillors should be noted**
- **It was felt by the public that Councillors are not attending Parish Council Meetings on a regular basis- Attendance sheet to show attendance percentage**
- **Children area needs health and safety inspection**
- **It was pointed out that the Allotments were once again broken into. Report was filed to the Police- Dummy cameras need to be considered**
- **It was pointed out that to improve recycling in Wexham more bins are needed- Environment Services at SBC to be contacted**

322. Information report from Members and Borough Councillors

- **Cllr Sohal reported that he has put forward a work list in the Wexham area amounting to £57k. The work suggested is on Almons Way, Mansell Close and The Cherries. Three Slough Borough Councillor`s for the Wexham Area are going to be using their Councillor fund, toatal £72k, to improve the grass verges in the Wexham area.**
- **Cllr Malik suggested that a camera be considered near the shops as rubbish is always being tipped there.**
- **Cllr Fayyaz suggested that a practice cricket patch be considered with nets next to the tennis courts. He also reported that he attended a meeting on community cohesion and roles for the Councillors at the Pakistan High Commission.**
- **It was suggested that spot lights be considered for the Cherries park.**
- **Cllr Fayyaz that hedges next to the Allotments at 377 Uxbridge Road have not been cleared as the the sum of £100 allocated to the job was not sufficient. The Clerk to get a quote from the handyman used for other works at the Hall.**

324. Outside Gym at The Cherries

- **The Cherries Gym construction and equipment final costs are as follows;**

325. Berryfield - Green space and path development

- **It is proposed that the Three Borough Councillors will contribute £25k if the Parish contributes the other £25k.**
- **It was concluded that a more accurate costing is needed before a decision can be considered. The Highway from SBC to be invited to next Parish Council meeting.**
